Fee Schedule for Use of Church Facilities for Non-members

Non-church functions and meetings

Use of sanctuary	\$300.00
Use of fellowship hall, no food served	\$100.00

Receptions

CVCC provides space for groups to hold receptions or meetings where food may be served. At these events, the kitchen may be utilized and food served in the fellowship hall only. The party holding the event must provide its own food, refreshments, tableware, basic clean up and removal of trash. CVCC will provide use of tables and chairs, use of fellowship hall and kitchen and use of dumpster. Fees for receptions are as follows:

Groups up to 50 persons	\$150.00
Groups of 50 to 100 persons	\$200.00
Groups over 100 persons	\$250.00

Please Note

- All of the above are minimum fees
- Fees may be higher depending on the size and duration of the event
- Use of facilities and fees are subject to the discretion and approval of the Church Council
- All parties must abide by the Rules Governing Use of the Church
- No smoking is allowed in the church building
- No food or drink is allowed in the sanctuary
- Fees may be reduced for non-profit organizations at the discretion of the Church Council

Receptions

Families are invited to provide catered food and refreshments. The family or caterer must provide all food, refreshments, tableware, basic clean up and removal of trash. CVCC will provide use of tables and chairs, use of fellowship hall and kitchen and use of dumpster. Fees for receptions are as follows:

Groups up to 30 persons	\$100.00
Groups of 30 to 50 persons	\$150.00
Groups of 50 to 100 persons	\$200.00
Groups of over 100 persons	\$250.00

- All parties must abide by the Rules Governing Use of the Church
- No smoking is allowed in the church building
- No food or drink is allowed in the sanctuary
- Pastoral Services fee is normally paid by the funeral home to the pastor and is typically included in costs paid by the family to the funeral home.
- Fees for sanctuary use, reception hall use and custodian are paid directly to the church by the family
- Fee for the organist is paid directly to the organist by the family

Receptions

Families are invited to provide catered food and refreshments. The family or caterer must provide all food, refreshments and tableware. Groups up to 30 persons	\$50.00
Groups of 30 to 50 persons	\$100.00
Groups of 50 to 100 persons	\$150.00
Groups of over 100 persons	\$200.00

Please Note

- Use of facilities and fees are subject to the discretion and approval of the Church Council
- All parties must abide by the Rules Governing Use of the Church and the Church Wedding Policies
- All fees shall be paid in full no later than the time of the wedding rehearsal. Fees are subject to change until the deposit has been paid
- A \$100.00 non-refundable deposit shall be made to reserve the date on the church calendar. The deposit will be credited towards the sanctuary use fee
- Service arrangements and fees for the organist shall be made directly with the organist
- Fees for sanctuary use, custodian and hall rental shall be paid by cash or check to CVCC prior to the wedding service
- The Pastor's fee may be paid by cash or check directly to the Pastor. Half of the Pastor's fee is due prior to the first premarital counseling session. The balance is due at the time of the rehearsal. The Pastor's fee includes an initial planning meeting, 3 premarital counseling sessions, the rehearsal and the ceremony.
- The Pastor of CVCC shall participate in all weddings performed in the church. However, duly ordained clergy are welcome to participate or assist and in special circumstances, with prior approval, may be permitted to conduct the wedding without the CVCC Pastor
- No smoking is allowed in the church building
- No food or drink is allowed in the sanctuary

*There is no required fee for the Pastor for church members or their children, however an honorarium is suggested. The suggested Pastor's honorarium includes an initial planning meeting, 3 premarital counseling sessions, the rehearsal and the ceremony.

**There is no required fee for sanctuary use for church members or their children, however a donation is encouraged.
